CARB basically wants input from the ACCC, the collector vehicle hobby, as well the SCV industry regarding a procedure to certify SCV's engine packages being brought forth by the major engine manufacturers. The meeting was a great step forward in our business and working relations with the CARB staff. More meetings are scheduled and I will keep you all posted on our progress.

AB 390 (Portantino) Vehicles: identification cards: notification of renewal. (E-08/16/2011 html pdf) Status: 08/15/2011-Senate amendments concurred in. To Engrossing and Enrolling. (Ayes 77. Noes 0.). Current Location: 08/15/2011-A ENROLLMENT

Summary: Existing law requires the director of the Department of Motor Vehicles to establish a program that permits the renewal of identification cards by mail or through the department's Internet Web site. This bill would require the department, no less than 60 days prior to the expiration date of a person's identification card, to provide the person with a written notice of the expiration date.

Summary: Existing law authorizes specified air pollution control and air quality management districts to adopt a fee applicable to motor vehicles registered in counties within that district, and requires the fee to be collected by the Department of Motor Vehicles. Existing law, until January 1, 2015, authorizes the amount of the fee to be up to \$6. Existing law requires the revenues from the first \$4 of the fee to be used for specified purposes. Existing law requires that the revenues from the last \$2 of the fee be used for specified programs that the district determines remediate air pollution harms created by motor vehicles, including purchases of new schoolbuses pursuant to the State Air Resources Board's Lower-Emission School Bus Program. This bill would additionally authorize a district based on that determination to use the last \$2 of the fee for programs to replace onboard natural gas tanks on schoolbuses owned by a school district that are 14 years or older, with a funding amount not to exceed \$20,000 per bus and to enhance deteriorating natural gas fueling dispensers of fueling infrastructure operated by a school Bus Program. This bill contains other related provisions.

Summary: Existing law requires the State Energy Resources Conservation and Development Commission (commission) and the State Air Resources Board (board), in consultation with other state and local agencies the commission deems necessary, to develop and adopt recommendations for the Governor and Legislature on a California Strategy to Reduce Petroleum Dependence. Existing law also requires the commission, in partnership with the board, to develop and adopt a state plan to increase the use of alternative transportation fuels. This bill would require the commission and the board to, among other things, adopt policies and regulations to attain the fuel consumption targets set forth in state plan to increase the use of alternative transportation, and investments affect the attainment of the fuel **consumption** targets. The bill would require the commission and the board deem necessary, to update a specified economic analysis, develop a strategy for petroleum fuel use reduction and alternative fuel use in specified vehicles, and identify regulatory and statutory barriers to attaining the petroleum fuel consumption targets. Summary: Existing law requires the Department of Motor Vehicles to refuse registration, or renewal or transfer of registration, for any commercial motor vehicle with a declared gross or combined gross vehicle weight that exceeds 10,000 pounds if the owner or operator of the motor vehicle at the time of the application has been cited for a violation of specified air quality standards pertaining to that vehicle or regulations adopted by the State Air Resources Board (board), until the violation has been cleared, as determined by that board. This bill would require the department to refuse registration for any commercial motor vehicle subject to registration that is of a 1996 or older model year with a gross vehicle weight rating of more than 26,000 pounds, except for any construction truck that is subject to an extension pursuant regulations adopted by the board as determined by the department. This bill contains other related provisions.

Summary: Existing law imposes specified licensing and regulatory requirements on dealers of motor vehicles and requires that specified fees and charges be disclosed in a conditional sales contract for the purchase of a motor vehicle. Existing law also prohibits any person from driving, moving, or leaving upon a highway any motor vehicle subject to registration under the Vehicle Code, unless it is registered and the appropriate fees have been paid under that code, and existing law authorizes the Department of Motor Vehicles to establish contracts for electronic programs that allow qualified industry partners to join the department in providing services that include processing and payment programs for vehicle registration and titling transactions. This bill would, beginning July 1, 2012, revise and recast these provisions and would require a motor vehicle sold or leased by a new motor vehicle dealer to be registered by the dealer using electronic programs provided by a qualified private industry partner, would require the dealer to disclose any document processing charge or electronic registration or transfer charge, and would establish the charges that a dealer may charge the purchaser or lessee of a vehicle. This bill contains other related provisions and other existing laws.

Summary: Existing law requires the California Alternative Energy and Advanced Transportation Financing Authority to establish a Property Assessed Clean Energy (PACE) Reserve program to assist local jurisdictions in financing the installation of distributed generation renewable energy sources or energy or water efficiency improvements meeting specified requirements that are permanently affixed on real property through the use of a voluntary contractual assessment. Existing law, until January 1, 2015, appropriates up to \$50,000,000 from the Renewable Resource Trust Fund to the authority for the purposes of the PACE Reserve program and authorizes the authority to expend up to \$300,000 of that appropriation for initial administrative costs in implementing the PACE Reserve program. This bill would additionally require the authority to administer a Clean Energy Upgrade Program that would be developed by the State Energy Resources Conservation and Development Commission and the authority to reduce the costs to property owners of a loan provided by a financial institution that has a loan program that satisfies the specified requirements. Because this bill would authorize the use of the money appropriated for the PACE Reserve program for the Clean Energy Upgrade Program, this bill would make an appropriation. The bill would require the authority to report annually specified information regarding the program. The bill would increase the amount of the appropriation that may be expended for initial administrative costs to \$550,000, thereby making an appropriation. This bill contains other related provisions and other existing laws.

Summary: Existing law requires the amount appropriated by the Legislature for the use of the Department of Motor Vehicles and the Franchise Tax Board for the enforcement of the Vehicle License Fee Law to be calculated as specified and transferred from the Motor Vehicle L icense Fee Account in the Transportation Tax Fund to the Motor Vehicle Account in the State Transportation Fund. This bill would allocate to the Department of Motor Vehicles (DMV), from the amount calculated under this provision, \$25,000,000 for the 2011-12 fiscal year and would deem that amount as the cost to the DMV for the collection of the motor vehicle license fee. Summary: Existing law requires the amount appropriated by the Legislature for the use of the Department of Motor Vehicles (DMV) and the Franchise Tax Board (FTB) for the enforcement of the Vehicle License Fee Law to be calculated as specified and transferred from the Motor Vehicle License Fee Account in the Transportation Tax Fund to the Motor Vehicle Account in the State Transportation Fund. This bill would instead require the Legislature to determine and appropriate annually an amount for the use of the DMV and the FTB for the enforcement of the Vehicle License Fee Law. SB 519 (La Malfa) Smog check: visual inspection. (A-03/25/2011 html pdf)

Status: 05/10/2011-Failed Deadline pursuant to Rule 61(a) (2). (Last location was B., P. & E.D. on 4/26/2011) Current Location: 05/10/2011-S 2 YEAR

Summary: Existing law establishes a motor vehicle inspection and maintenance (smog check) program, developed, implemented, and administered by the Department of Consumer Affairs. The smog check program provides for the inspection of a motor vehicle, among other circumstances, upon its initial registration, upon transfer of ownership, and for vehicles registered in certain areas of the state, biennially upon renewal of registration. A violation of smog check requirements is a crime. Existing law requires the smog test to include a visual or functional check of emission control devices specified by the department. This bill, notwithstanding this provision, would prohibit a smog check technician from conducting an under-the-hood visual inspection as part of a smog check inspection. Because a violation of this prohibition would be a crime, the bill would impose a state-mandated local program. This bill contains other related provisions and other existing laws.

SB 901(**Steinberg**) Air pollution: vehicle retirement program. (I-02/18/2011 html pdf)

Summary: Existing law creates the High Polluter Repair or Removal Account in the Vehicle Inspection and Repair Fund, and makes moneys deposited in the account available, upon appropriation by the Legislature, to the Department of Consumer Affairs and the State Air Resources Board to establish and implement a program for the repair or replacement of high polluters. Existing law also creates a program for the voluntary retirement of motor vehicles that are high polluting vehicles, administered by the Bureau of Automotive Repair pursuant to guidelines adopted by the state board, to be funded from the Enhanced Fleet Modernization Subaccount in the High Polluter Removal and Repair Account. This bill would make this program available only to the highest polluting vehicles, with priority given to those highest polluting vehicles registered in air basins that are out of attainment with federal air quality standards. The bill would make other technical changes.

MAKING YOUR COLLECTOR CAR A HISTORIC TREASURE

The HVA's mission is to keep "Yesterday's Vehicles on Tomorrow's Roads" by establishing a collaborative platform among historic vehicle enthusiasts.

HVA group seeks to extend National Historic Preservation Act to the automobile.

Should your historic vehicle have the same cultural status and favorable regulatory treatment as historic buildings? That was an intriguing question for the HVA. After taking the idea out for a test drive, it appears that the answer may hold the key to long-term, significant benefits for collector cars.

Historic buildings, airplanes, canoes, gas stations and strips of highway have all found official recognition, status and protection under the National Historic Preservation Act of 1966. It's an odd quirk that the most significant invention of the 20th century has yet to take its formal place alongside buildings and other transportation-related sites and historic objects.



While there are many possible reasons for the omission of collector cars in the existing framework, there is one reason that quickly comes to mind: Thinking of our "iron" as historic or culturally significant is counterintuitive to most collectors. The typical collector is more motivated by nostalgia than the thought of preserving a vehicle or being a steward of a piece of history.

We are in our early stages of exploration on this idea, but we have had encouraging dialogue and feedback from a number of prominent collectors and historians inside and outside the collector car world about the benefits of including collector cars in the National Historic Preservation Act. In our initial research we found that inclusion under the Act is always voluntary, and the rights of the property owner remain intact. We aren't interested in pursuing any initiative that would create more red tape or allow the government to tell us how to use our cars.

We will keep you updated on our progress as we develop the details of our "Drive History" initiative. In the meantime, if you or your club have feedback or comments, please submit them below.


