Introduction

Documenting Visibility: A Selected Bibliography of Lesbian and Bisexual Women's Health brings together literature published between 1990 and 2000. Developed as a tool for researchers, educators, health practitioners and policy makers, this bibliography makes readily available references to qualitative and quantitative health studies that focus substantively on women who identify as lesbian or bisexual. Prepared by using on-line databases and networking with community and university based researchers, one of our goals was to identify contemporary Canadian research into queer women's health issues, health experiences and health status. Publications known to contain Canadian content are highlighted throughout the bibliography.

Bibliographies capture a body of literature at a particular moment in time, offering insights to the cultural and political contexts which influence research topics and funding for both research and the dissemination of results. For example, Janice Hitchcock (1989) provides readers with valuable references from 1960 to the mid-1980s which examine "homosexuality" and "lesbianism" from clinical and psychologizing perspectives. Also included in Hitchcock's bibliography is an emerging body of literature aimed at depathologizing the "difference" of being lesbian or gay and revisioning lesbian and gay health issues. Liza Rankow (1995) demonstrates a shift in "lesbian health" research; an earlier emphasis on the study of "lesbianism" was replaced by research focusing on lesbian and bisexual women's health care interactions and experiences of health and illness. Documenting Visibility was prepared in order to provide access to studies published over the past decade. While for the most part limited to Canadian and American English publications, the references in this bibliography provide a sense of the on-going development of lesbian and bisexual women's health knowledge and the ways in which this growing field of research is shaped by contemporary perspectives on identity, sexuality, gender, women's health and the social determinants of health. Coming Out to Health Professionals (Disclosure)

Materials in this section deal with aspects of disclosure between gays or lesbians and health and social services providers or between providers who are gay or lesbian and the people they serve. One contribution of these materials is the recognition that disclosure operates in both directions and that it is not only the identity or behaviour of patients or clients which operates in the dynamics of the provision of health care but also that of the provider. Issues of disclosure include aspects of "coming out", the risks of disclosing one's sexual orientation, and cultural diversity as it relates to disclosure.
