#### **OPENING SESSION:**

"The Millennial Student and Trends in Higher Education" . . . . Glenn Trammel (SunGard) 8:45 a.m., Monday

DESCRIPTION: On average, these members of the <u>Class of 2010</u> will be 18 years old, which means they were born in 1988, according to list owners, this year's entering students form "a generation that has always been 'connected' and is used to things happening in 'real time,' like live satellite coverage of revolutions and wars, instant messaging and movies on demand. They expect solutions for every problem, from baldness to diseased organs. To the chagrin of teachers and parents, they've developed their own generational means of communication." These millennial students are certainly a priority for institutions of higher education. However, lets also explore the nontraditional learner and their ever increasing presence on and off campus. Finally, we will take a look at emerging technology trends in higher education.

Although this session is somewhat technical, it will be helpful for end users to see how simple it can be to retrieve a report through Argos.

This product has evolved from an audit package that Pearl River had developed—a special thanks Pearl River.

5. Official Payments: "Are you paying too much for your Payment Gateway/

**Processing?" (T, R)** ..... Stephanie Miller (Marketing, TIER Technologies) 9:00 a.m., Tuesday

DESCRIPTION: Official Payments offers a completely hosted PCI Level I compliant

eCommerce Payment Solution and is a member of the SunGard High Education Collaborative partner program. Our payment solution supports American Express, Discover, MasterCard and VISA, as well as eCheck payment options. The Official Payments solution includes eBill and payment plans at no additional cost.

6. **CAPP (S)** ...... Bettye R. Graves (JSU) 9:00 a.m., Tuesday

DESCRIPTION: This session will cover implementation and training of the CAPP–Curriculum, Advising Program Planning–system. The presenter will show and demonstrate the methods for building an academic program and applying the requirements to a student's academic history data.

7. **IPEDS Race/Ethnicity Changes** 

*DESCRIPTION:* Last October the U.S. Department of Education issued final guidance on maintaining, collecting, and reporting racial ethnic data. IPEDS will adopt new aggregate categories for reporting and institutions will be required to implement these categories by the 2010-2011 school year. This session will focus on explaining the nuances of the final guidance issued by the Department of Education and offer recommendations for dealing with the changes.

8. Disaster Recovery/Replication Model—"Best

**Practices for Tight Budgets" (G, T)** ...... Dennis Nelson, Austin Laird (Oracle) 1:30 p.m., Monday

DESCRIPTION: Learn how to maximize your Banner Database uptime and minimize new investment in disaster recovery technologies! We'll discuss best practices around utilizing Oracle Dataguard (an included feature of the Oracle Database) and discuss disaster recovery strategy. Bring your questions and your input about this topic for an informative and interactive session.

9. **Employee Self Service (H)** ...... Edith Riley (MSU) 9:00 a.m., Tuesday

*DESCRIPTION:* Mississippi State University Enterprise Information Systems delivers a version of ESS to the campus consisting of selected out-of-the-box functionality as well as significant modifications and add ons. This session will present an overview of the product available to both the general employee population as well as administrative personnel.

10. **Workflow and Xtender Implementation at MSU (S, M, T)** . . . Tommy Parker (MSU) 10:15 a.m., Monday

*DESCRIPTION:* This presentation will demonstrate how Mississippi State University has streamlined several of our business processes by means of Banner Workflow and the Banner Document Management Suite (Formerly Xtender). Included will be an overview of 3 different workflows being used by Undergraduate Admissions, Graduate

Admissions, and the Registrar's Office for processing of applicants and student information.

The Banner Document Management Suite compliments each of these workflow processes by storing all the necessary application documents electronically, allowing offices and departments to immediately view these documents online, thereby eliminating paperwork and reducing bottlenecks.

Also being discussed are some of the basic concepts of workflow, such as the workflow modeler, how a workflow gets started, how workflow interacts with the Banner database, routing, custom forms, email, proxies, roles, etc.

This presentation is intended for both functional and technical users who are interested in implementing workflow, mainly in a study system context. However, there are many aspects of these processes that could be applied to other functional areas as well.

*DESCRIPTION:* My presentation can be described as FERPA-AT-A-GLANCE: A Brief Overview of Basic FERPA Guidelines. This information may be used to assist in implementing institutional record-keeping policies. This presentation may be of particular interest to first-time registrars and admissions officers. (I do not claim to be an expert in this area.)

This session will discuss and review steps and forms necessary for implementing and utilizing Banner on-line approvals.

### 15. **SOACURR (Curriculum Rules Form)**

*DESCRIPTION:* This session will discuss the purpose behind program codes and curriculum rules. We will go over the creation of program codes and the inactivating of program, major, concentration, and minor codes on SOACURR. We will also discuss what to do when a major changes to a different department or college.

# 16. **New Trends in Strategic IT Planning (T)** ..... Andrew Nagorski (SunGard) 3:15 p.m., Monday

DESCRIPTION: When the rapids of changing technology meet the more practical constraints of staff retention and budget availability, a classic rethink of strategic IT planning can create a dynamic new flow of institutional thought. This "Ready-Fire-Aim" process has become popular in the past year with many higher education institutions reaiming, or often creating, their strategic IT plan.

18. **Business Process Management (G)** . . . . . . . . . . . . . Glenn Trammel (SunGard) 9:00 a.m., Tuesday

DESCRIPTION: The key to effectiveness in any institution is in its business processes. The processes include every step and activity that must occur to achieve a particular outcome. When the business processes are out of control, occur to slowly, or fail, the institution cannot succeed. In this break out session, we will examine the business process management process, enrollment management, and electronic document

management. This examination will provide insights into how to improve business processes through effective utilization of technology tools.

# 19. **Distributed Payroll Time Entry (H)** ...... Edith Riley (MSU) 3:15 p.m., Monday

*DESCRIPTION:* The Mississippi State payroll implementation in 1995 included the rolling out of exception time entry to departmental offices around the campus and state. For the end of July payroll, 163 departmental payroll users entered exception time for a possible 3,763 non-exempt employees in 287 orgs. This session will include a review of Org Level security setup, as well as a presentation of MSU add-ons.

#### 

DESCRIPTION: Before you touch that button. . . let's talk about the DATA! As most of you are aware, Banner provides institutions an increase in the quantity and quality of information that is easily accessible, secure, and compatible across functional areas of responsibility. One of the most critical elements of managing the data is - maintaining accuracy and integrity. In this session, we will discuss the significance of establishing data standards for your institution and how these data standards impact Advancement.

# 21. **No Future Funds for Old Bills (F, R)** . . . . . . Nedra Bradley, Trina Wilson (MCC) 3:15 p.m., Monday

DESCRIPTION: Over the past year and a half, various changes have occurred and additional guidelines have been implemented within the financial aid industry. This fall, the U.S. Department of Education published new regulations pertaining to the disbursement of federal aid funding and its management by school officials. This session will review the practices of disbursing federal student aid funds, including an examination of using this type of funding to help with prior-year charges.

## 22. **EMS Campus Scheduling Software (S, G)** . . Nikki Rusconi (Events Mngmt. Systems) 10:15 a.m., Monday

DESCRIPTION: Learn more about one of our most in-demand products: EMS Campus. EMS Campus provides a single program that suits both your academic and event scheduling needs. Banner allows users to capture these charges and post them automatically. Yes, you no longer have to manually calculate and post the charges to your institution's general ledgers. Just set up a few tables in Banner and you are on your way. This presentation will help the users who want to implement this process get started. 25. E-Verify (H) ...... Marilyn Sauls (Mississippi College) 1:30 p.m., Monday DESCRIPTION: Effective July 1, 2008, Governor Haley Barbour made it mandatory for all employers in the State of Mississippi to use E-Verify. Employers that depend on Federal Contracts are also mandated to use E-Verify. Educational institutions, due to the nature of the institution, will meet obstacles to timely reporting. We will discuss problems that institutions of higher education may encounter. 26. End2End ARMS System (G) . . . . . . . . . Jennifer Downs (ARMS 9:00 a.m., Tuesday DESCRIPTION: This system is a campus police incident reporting/parking system. 27. **Reporting Nightmares Minimized Utilizing** Microsoft Access (G, R) ..... Janieth Adams, David Howard (JSU) 10:15 a.m., Monday DESCRIPTION: This session will show how MS Access can be used for reporting needs. Focus will be on creating queries, reports and forms, including switchboards, which allow end-users to click on buttons to retrieve real-time data (primarily in the form of Excel spreadsheets and reports), without needing to learn MS Access. We will show examples from the Finance and Payroll areas; however, MS Access can be used for any area. 28. **Transfer Articulation (S)** . . . . . . . . . . Kimberly Saving-Sherman (SunGard) 3:15 p.m., Monday DESCRIPTION: Are you using transfer articulation? If not, come to this session to learn how to set up the transfer articulation functionality and how to use it. 29. **Best Practices for Effective IT Security (T)** . . . . . . Andrew Nagorski (SunGard) 10:15 a.m., Monday

*DESCRIPTION:* The security of an institution's data is growing area of concern within higher education. We read about a different type of breach every week. Our academic mission is to obtain, enrich and share information. How do we protect administrative data from the growing threats of breach and compromise? (See #16 for Speaker Bio.)
