NAR Urges New Regulations to Combat Deceptive Lending

The financial markets are struggling with the results of abusive lending practices in the subprime market, including the collapse of several investment funds and the failure of more than 100 subprime lenders. [Click here](#) to see the letter to the Federal Reserve System Board of Governors. NAR urged the Board to adopt regulations that combat unfair, deceptive, and abusive mortgage lending acts and practices. Among its recommendations: NAR asked the Fed to eliminate prepayment penalties for all categories of mortgages or to bar prepayment penalties for subprime mortgages and other mortgages where abuses are found. NAR also urged the Board to require that subprime lenders mandate an escrow reserve for taxes and insurance.

Technology Tip

How to Improve Your E-mail Communication. . .

- Don't use e-mail as your only form of communication
- Keep your messages short and don't allow your exchanges to go on too long before you switch to face-to-face contact.
- Make your subject line clear and only send your message to people who will benefit from the information. Encourage questions in response to your message.
- Keep up with your e-mail every day.
- When you are angry, do not express yourself through e-mail. Save it for a face-to-face meeting.
- A little humor is good, but too much could affect your attempts later when you need to send serious information.
- Set a five-minute rule. Wait five minutes before you send a message. The delay will give you time to correct a poorly written phrase or change your mind about sending the e-mail at all.
